- Represents a portion of the RSUs that vested on May 17, 2025 (1,529 of which were cash settled in an amount approximately equivalent to taxes associated with such vesting).
- Represents 4,132 RSUs that vested on May 17, 2025 and 4,133 RSUs that, subject to the reporting person's continued service, will vest on May 17, 2026.
